

Columbia River Circuit Finals Rodeo Vendor Contract

This agreement is made and entered into this _____ day of _____, 2011
Between the Columbia River Circuit Finals Rodeo and _____,
hereinafter referred to as the "Vendor".

In consideration of the payment hereinafter specified, the Columbia River Circuit Finals Rodeo gives the Vendor the right to operate and maintain an area designated to the Vendor as space for the duration of the 2011 Columbia River Circuit Finals Rodeo being held at the Deschutes County Fairgrounds in Redmond, OR.

Vendor will pay a \$100.00 non-refundable deposit by October 28, 2011, the balance due must be paid upon check in. Any cancellations they must notify the Vendor Chair within 15 calendar days prior to the rodeo to receive a refund minus the deposit. Each vendor will receive 3 wrist bands for the entire weekend. Additional wrist bands may be purchase for 15.00. Booths are 10X10 at \$250 or 10x20 at \$500, multiple booths are available. Tables are supplied by Fair Grounds for an additional fee. There is shared electricity on the wall area approximately every 15 feet, so you will need to bring your own extension cords. If you require a phone line for Visa or Debt Cards, you must contact the Deschutes County Fairgrounds in advance.

Vendors can start checking in on Thursday November 10th. Booth must be set up and ready to do business by 3 p.m. on the Friday before the event, and out by Sunday at noon

The Columbia River Circuit Finals Rodeo Shall:

*Permit the vendor to occupy said space for the purpose of displaying, demonstrating, selling or operating as follows: During the Columbia River Circuit Finals Rodeo (November 11th and 12, 2011)

*No space may be vacated until the end of the Performance on Saturday, November 12th, the last day of the Rodeo.

*The Vendor shall indemnify and hold the Columbia River Circuit Finals Rodeo, its officers, employees and agents harmless from any and all claims for damages to person or property arising out of or related in any way to the operation of the Vendor's booth, or Vendors activities while on the Deschutes County Fairgrounds, including all reasonable attorney fees and costs incurred by CRCFR in defending against any of such claims.

The Columbia River Circuit Finals Rodeo Shall Not Provide:

- * Liability insurance for the Vendor
- *Security in off hours (not during performance times) of the event
- *Extension cords or other accessories related to the production of goods and services

The Vendor Shall:

*Staff the exhibit space during the hours that the Columbia River Circuit Finals Rodeo is open to the public.

*Dispose of garbage and debris at places designated by the Columbia River Circuit Finals Rodeo.

*Leave the premise in a clean and orderly condition

*Abide by all general conditions, rules, and regulations written or oral, made by CRCFR from time to time governing conduct during the CRCFR and the Deschutes County Fair Association.
